\*\*\$500 total is due 30 days prior to trip. \$250 will hold reservation up to 30 days prior. This is in addition to the rental amounts.

**Security Deposit and rental fees must be paid prior to execution of the rental. The security deposit is held. See rules.**

\*This discount of 15% can be applied to all additional consecutive weeks booked 30 days in advance. See rate schedule.

I understand that the \$500 security deposit must be paid and received by St Johns RV at least 30 days in advance of my reservation, in order to hold that reservation. If the entire \$500 security deposit is not received by St Johns RV prior to 30 days in advance of the reservation, St Johns RV will assume that I have decided by my inaction, to cancel the reservation. I understand that St Johns RV will no longer be obliged to hold my reservation. I understand that the security deposit is an additional payment not a partial payment of the actual rental fees.

If I wish to cancel the rental, I must notify St Johns RV at least 30 days in advance of my reservation to receive any refund. By notifying St Johns RV of intended cancellation prior to 30 days, I will be refunded one-half (\$250) of the deposit (assuming the deposit was the entire \$500 required). If I do not show or are unable to pay for the rental for any reason prior to the scheduled rental day, the entire \$500 security deposit is forfeited. Simply put, if I can not execute this agreement for any reason, I understand that I forfeit my deposit. The exception is the 30 day notice stated above.

In the event that I must cancel for any reason, it is my understanding that St Johns RV will make the rental dates available that I was holding with my deposit. Should someone else rent from St Johns RV, any portion of the dates I reserved, St Johns RV will refund a portion of my deposit equal to the amount collected in basic rental fees, less a \$25 service fee associated with this transaction. As an example, if I was reserving for 1 week and cancelled, but someone else rented the exact dates I reserved, St Johns RV would refund from my \$500 deposit, \$475. If I had only made the \$250 portion of the deposit prior to 30 days and cancelled prior to 30 days, St Johns RV would refund \$225 in the above example.

In very simple terms, St Johns RV is willing to return portions of the deposit forfeited due to cancellations, in cases where we can recover expenses with new rentals for the same time period of the reservation in discussion. St Johns RV will allow this policy to work also in times where only a day or more is recovered with new rentals, thus allowing at least some portion of the deposit to be returned were possible.

### Additional Requirements:

- 1) The reservation/security deposit must be received along with a signed contract to secure the vehicle and rental dates you want.
- 2) Drivers must be at least 25 years old and have a valid license.
- 3) Provide a copy of your driving record.  
You **do not** have to obtain a driving record **until** we have confirmed your reservation. Allow at least one week to receive your records from the State of Michigan which can be obtained from the Secretary of State online service or by calling 517-322-1624. Your insurance carrier may also be able to provide you with a copy of your record. If you have a generally good driving record (a few minor violations), this will not be an issue. Bring your driving record with you when you pick up the motorhome.
